
OFFICE MEMORANDUM

Subject: - NOC FROM ESTABLISHMENT DIVISION IN CONNECTION WITH FRESH APPOINTMENTS TO CIVIL POSTS (BPS-1 TO BPS-15) PAID OUT OF DEFENCE ESTIMATES WITHIN ERSTWHILE MVRDE, ARDE AND IOP (NOW DGRDE).

The undersigned is directed to refer to M/o Defence Production's O.M No. 6/3/2014-DP-8 dated 23<sup>rd</sup> May, 2023 on the subject noted above and to state that obtaining a prior NOC from this Division is mandatory before making specified kind of recruitment. Moreover, requisite staff with matching qualification, experience and grade is not available in the surplus pool for absorption against the reported vacant posts. Therefore, Ministry of Defence Production may fill 44x vacant posts i.e. 03x Supervisor (Upper Grade) (BPS-15), 01x Data Entry Operator (BPS-14), 01x Chargeman (BPS-12), 01x Supervisor A (BPS-11), 06x LDC (BPS-11), 02x Carpenter (BPS-11), 01x Senior Production Technician (BPS-09), 01x Store Keeper (BPS-07), 01x Gate Keeper (BPS-07), 03x HS-II (BPS-06), 05x Junior Production Technician (BPS-05), 02x Storeman (BPS-05), 01x Laboratory Attendant (BPS-05), 01x Auto Technician (BPS-05), 01x Civ Driver (BPS-04), 01x Duplicate Machine Operator (BPS-04), 02x Fireman (BPS-02), 01x Chowkidar (BPS-01), 01x Mali (BPS-01) and 09x Naib Qasid (BPS-01) in DGRDE (erstwhile MVRDE, ARDE and IOP) under that Ministry as mentioned in the OM under reference in accordance with the approved recruitment rules of the posts subject to completion of all codal formalities and in line with the directions of this Division's Recruitment Policy dated 22-10-2014 as amended from time to time and mechanism dated 16-01-2015 as amended from time to time.

2. This NOC is valid for a period of six (06) months from the date of its issuance. However, according to para 1-(xiii) of recruitment policy guidelines dated 22-10-2014, as amended on 21-9-2017, 27-12-2018 & 04-3-2019 recruitment is required to be finalized within 120 days from the date of advertisement.

3. The advertisement to be published for recruitment may be forwarded by the concerned Ministry/Division directly to Press Information Department, Information & Broadcasting Division. However, the appointing authority of the concerned Ministry/Division/Department/Organization shall ensure completion of all procedural and codal requirements in letter & spirit in line with the Recruitment Policy while making recruitment and will be held responsible for illegality if any
