

Islamabad, the 30th May, 2022

S. R. O. 698(I)/2022.—In exercise of the powers conferred by subsection (1) of section 25 of the Civil Servants Act, 1973 (LXXI of 1973) read with Notification No. S.R.O. 120(I)/98, dated the 27th February, 1998, the Prime Minister is pleased to make the following rules, namely:—

1. **Short title and commencement.**—(1) These rules shall be called the Civil Servants (Directory Retirement from Service) (Repeal) Rules, 2022.

(2) These rules shall come into force at once and shall be deemed to have taken effect on and from commencement of the Civil Servants (Directory Retirement from Service) Rules, 2020.

2. **Repeal.**—(1) The Civil Servant (Directory Retirement from Service) Rules, 2020 are hereby repealed.

(2) On repeal under sub-rule (1), any actions taken, proceedings initiated, pending or concluded, recommendations or decisions made, orders passed or notifications issued under the repealed rules are hereby recalled and shall have no legal effect whatsoever and no inferences shall be drawn against civil servants affected or suffered under the repealed rules solely for the reason that proceedings of directory retirement under the repealed rules were initiated or finalized.
