As per the Prime Minister's directive, issued vide this Division's DO letter No.5/11/2000-T-II/T-I dated 10-06-2014, this Division's OM No. No.5/11/2000-T-II/T-I dated 11-07-2019 and OM No. 4/4/2021 dated 15-02-2022, all Ministries/Divisions/ Departments are bound to relieve officers on their selection for training course without fail. The Ministries/ Divisions / Departments shall make stop-gap arrangements as the nominated officers are not required to attend their offices while undergoing training. Non-compliance of directions of the Prime Minister shall result in disciplinary proceedings under Civil Servants (Efficiency & Discipline) Rules, 2020. Moreover, under Rule 8(b) of the Civil Servant Promotion (BS-18 to BS-21) Rules, 2019, a civil servant shall be liable to supersession if he/she fails thrice for any reason to attend the mandatory training.

3. The course fee is Rs.2,169,462/- per participant. The payment of course fee in respect of officers of occupational groups and ex-cadre officers of all Ministries/Divisions and their attached departments will be made by the Establishment Division while in case of officers of the Provincial Governments and autonomous bodies/organizations etc. nominated for the course shall be arranged by their respective Government/Organization to the President NDU, Islamabad.

4. The newly selected officers as mentioned at S.Nos 15, 16 and 18 of Para 1, are required to confirm their availability for the course. In case of non-availability, the reasons thereof may be communicated by 16.5.2025.

5. All the selected officers are requested to forward the **requisite documents as per Annex- I (containing in CDs already communicated) to NDU directly as per the given deadline date i.e. 15.5.2025.**

6. All selected officers are required to deposit NADRA Covid-19 Certificate and Separability Certificate as per **Annex-II** while report to National Defence University (NDU) at 1000 hours on **09.08.2024** for familiarization visit / briefing.
