- 2. The course will be commencing from 29-05-2023 (Monday). The nominated officers may report to NIMs Karachi, Lahore, Peshawar, Islamabad and Quetta on 26-05-2023. The above nominations are subject to provision of latest Annual Medical Examination Reports to be submitted to respective NIMs.
- 3. It is also pertinent to mention here that the course fee for each participant for split program of MCMC is Rs.230,000/- (Rupees Two Hundred and Thirty Thousand) per participant at NIMs Karachi Lahore, Peshawar, Islamabad and Quetta (10 weeks) and Rs.64,286/- (Rupees Sixty-four Thousand Two Hundred and Eighty Six) per participant (4 Weeks) for Specialized Training Institutes. The payment of course fee in respect of officers of occupational groups and Ex-cadre officers of all Ministries/ Divisions and attached departments, nominated for the course, will be made by the Establishment Division while in case of officers of the Provincial Governments and autonomous bodies/organizations etc., it shall be arranged by their respective departments/governments etc., and payment to this effect shall be remitted to the respective Director General, NIM, through bank draft/cross cheque/pay order at the time of joining the course by the officer concerned or as early as possible.
- As per the Prime Minister's directive, issued vide this Division's D.O letter No.5/11/2000-T-II/T-I, dated 10-06-2014 all Ministries/Divisions/ Departments are bound to relieve the officers on their selection for training course without fail. The Ministries/Divisions/ Departments shall make stop-gap arrangements, as the nominated officers are not required to attend their offices while undergoing training. Non-compliance of the directions of the Prime Minister shall tantamount disciplinary proceedings under the Civil Servants (E&D) Rules, 2020. Further, according to Rule 8 (b) of the Civil Servants Promotion (BPS-18 to BPS-21) Rules, 2019, if the officer fails thrice for any reason to attend the mandatory training he will be recommended for supersession.
