- 2. The course will be commencing from 29-05-2023 (Monday). The nominated officers may report to NIMs Karachi, Lahore, Peshawar, Islamabad and Quetta on 26-05-2023. The above nominations are subject to provision of latest Annual Medical Examination Reports to be submitted to respective NIMs.
- It is also pertinent to mention here that the course fee for each participant for split program of MCMC is Rs.230,000/- (Rupees Two Hundred and Thirty Thousand) per participant at NIMs Karachi Lahore, Peshawar, Islamabad and Quetta (10 weeks) and Rs.64,286/- (Rupees Sixty-four Thousand Two Hundred and Eighty Six) per participant (4 Weeks) for Specialized Training Institutes.
