- 2. The nominated officers are required to report to the concerned Institute (NIM, Islamabad, Lahore, Karachi and Peshawar) as per the instructions of the respective NIMs.
- 3. Rule 22 of Civil Servants (Promotions) Rules 2019 delineates the procedure to be followed, in case an officer declines to proceed on mandatory training.
  - (1) The provincial governments or as the case may be, the ministries. Divisions and departments concerned may make a request for deferment from training of a civil servant only once.
  - (2) Any relaxation of sub-rule (1) shall require specific approval of the Prime Minister.
- Further, according to Rule 8 (b) of the Civil Servants Promotion (BPS-18 to 21) 4. Rules, 2019, if the officer fails thrice for any reason to attend the mandatory training will be recommended for supersession. The above nominations are subject to provision of latest Annual Medical Examination Report.
- 5. The course fee is Rs. 350,000/- per participant which covers the boarding and lodging expenses at the respective NIMs and expenses on mandatory inland/foreign study tour. The payment of course fee in respect of officers of occupational groups and ex-cadre officers of all Ministries/Divisions and their attached departments will be made by the Establishment Division while in case of officers of the Provincial Governments and autonomous bodies/organizations etc.

The same of the sa nominated for the course shall be arranged by their respective Government/Organization to the Director General, NIMs concerned through Bank draft/ cross cheque / pay order at the time of joining the course by the officer concerned or as early as possible.
