

 - (ii) Pre-qualification bids will be opened on above mentioned date at 11:00 A.M under supervision of the chairman purchase committee (i.e. Deputy Director (F&A) and member of purchase committee in the presence of firm's representatives.
3. Pre-qualification bids containing detailed terms and conditions are also available on official website of Establishment Division www.establishment.gov.pk and Public Procurement Regulatory Authority (PPRA) www.ppra.org.pk.
4. Single stage one envelope procedure as contained in Rule 36 (a) of PPRA Rules-2004 shall apply.
5. The Pre-qualification Committee may reject all bids or proposal at any time prior to the acceptance of bid or proposal while conveying the reason thereof in accordance with Rules 33 of PPRA Rules 2004.

The criteria for pre-qualification of Workshops for repair / maintenance of transport, machinery & equipment, furniture / fixture, Minor repair / maintenance of building, hardware/software, solarization and IT equipment items is as under:-

- i The interested Firm/Workshops must have five (05) years' experience in relevant field in the shape of work orders as well as performance certificates from 5 Government organizations proving satisfactory performance in the past etc.
- ii The Firm/Workshops must be registered with Sales Tax and Income Tax Department (FBR). Valid documents must be attached.
- iii 3 year bank Account maintenance certificate duly verified by Bank.
- iv Interested parties must attach non-black listing certificate on a fresh affidavit amounting to Rs.100/- with bidding documents, duly attested by notary public.
- v Bid security amounting to 5% of the amount in favour of DDO, STI, Secretariat Training Institute, Islamabad must be attached with bid in shape of pay order or Bank draft

TERMS & CONDITIONS

- i) Satisfactory performance certificate from five different organizations proving performance and presence of the Firm/Workshops for last five year and have not defected their office/workshop for the same period.
 - ii) The Firm/Workshops on the panel shall be bound to carry out the requisite work on immediate basis when repairs are referred to them even at odd hours/ public Holidays while ensuring quality and timely service in a transparent manner as and when required in accordance with all applicable laws, rules and regulations.
 - iii) While submitting rates the Firm/Workshops must clearly mention GST and all other applicable Government Taxes included in the offered rates or otherwise.
 - iv) The Firm/Workshops shall be bound to return old spare parts in case of replacement with new once.
 - v) Warranty period of each item replaced or repaired must be clearly mention in quoted rates besides ensuring its quality and durability. If the same defect appeared again, the Workshop (s) shall be responsible to replace free of cost.
 - vi) In case of refusal to undertake the work, the bid security of the item shall be forfeited and agreement cancelled.
 - vii) Earnest money shall be forfeited if a bidder is unable to provide services, defects or fails to ensure or provide quality service in a transparent manner, and shall be backlisted for future business with Government Departments as per PPRA Rules 2004. While cancelling the agreement with the bidder.
 - viii) Agreement will be concluded with the successful bidder for provision of said services in the light of all applicable, laws, rules and regulations, whose compliance will be ensured in any case by the bidder till its expiry.
 - ix) The pre-qualification of firm agreement will be made through open framework for two years under PPRA Rules 16
